COMPLEX RULES:

1. **NO ALCOHOLIC BEVERAGES ALLOWED ON PROPERTY**
2. **NO TOBACCO PRODUCTS ALLOWED WITHIN FENCED FACILITIES**
3. **NO GOLFING OF ANY KIND**
4. **NO UNAUTHORIZED VEHICLES ALLOWED INSIDE THE GATE. IF YOU HAVEN'T RECEIVED PERMISSION THIS YEAR THEN YOU ARE NOT AUTHORIZED**
5. **COACHES/MANAGERS ARE RESPONSIBLE FOR THEIR TEAM TRAINING SESSIONS. CLEANING UP AFTER YOUR PRACTICES...TRASH, EMPTY DRINK CONTAINERS ETC., ARE INCLUDED IN THESE RESPONSIBILITIES**
6. **GOALS ARE NOT TO BE MOVED THAT ARE IN PLACE ON FIELDS: FOR TRAINING PURPOSES MOVING THE EXTRA GOALS AT THE COMPLEX IS PERMITTED:**
 1. **GOALS NEED TO BE CARRIED AND NOT DRAGGED ACROSS THE FIELDS, AS THIS DESTROYS THE FIELDS**
 2. **THE GOALS NEED TO BE RETURNED TO THEIR ORIGINAL POSITION AND PROPERLY SECURED AFTER USE**
7. **TEAMS PRACTICING AFTER DUSK ARE RESPONSIBLE FOR INSURING ALL LIGHTS ARE TURNED OFF**
8. **COMPLEX CLOSES AT 10:00 P.M. ANYONE ON PROPERTY AFTER THIS TIME UNLESS AUTHORIZED WILL BE CONSIDERED AS TRESPASSING**

FAILURE TO ABIDE BY THESE RULES OR ANY ABUSE OF THE FIELDS OR FACILITIES WILL RESULT IN THE TEAM/CLUB, COACH/PLAYER/INDIVIDUAL BEING BANNED FROM THE COMPLEX.
